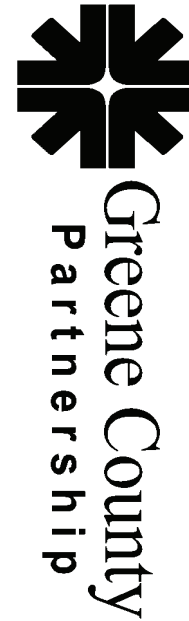

## Application

Crafters only should send five close-up color photographs (no larger than 3"x5") of different works to be exhibited, along with the craftsman's name and address on each photo. If photos are not included, your application will be discarded. A **\$5** application fee should also be included along with the application. **Crafters who have attended the show in the past do not have to send photos unless there have been changes in merchandise.**

## Fees

Application and booth fees (separate checks) **must** accompany entry form. Applicants that are accepted will receive acceptance letters. Applicants not accepted will receive notification letters which will include the booth fee check that accompanied the application.

AFTER MAY 3, 2012.**

## Eligibility

We reserve the right to remove any work which does not reflect the caliber of that presented in the slides or photos, or work considered to be in poor taste. All crafts, traditional and contemporary, including photography and painting, will be considered. All work must be original to the exhibitor. Any commercially-made embellishments must be subordinate to the handcrafted work.

## Sales

All sales must be handled by the exhibitor. Local sales tax must be collected. Tax materials will be in the registration packet received at check-in.

## Setup

Exhibitors are responsible for their own displays, including tables and tents. See calendar for set-up times. The show will be held, rain or shine, and each exhibitor should make arrangements for wind or rain. Arrangements have to be made in advance if you need electricity. **There will be an additional cost of \$20 for electricity.**

## Food Booth

Profit and non-profit food booths will be accepted on a first-come, first-served basis. Food vendors **will** be allowed to sell Coca-Cola products and will be charged a set fee. **All food vendors will pay \$300 per booth space plus the application fee of \$5.**

Please make checks payable to the Greene County Partnership and return completed application by **May 1, 2012.**

**\*\*\*\*Each vendor has 10 days following this year's festival to reserve the same location.**
