Application

Crafters only should send two close-up color photographs (no larger than 4 x 6) of different works to be exhibited, along with their names and addresses on each photo. If photos are not included, the application will be discarded. A **\$5** application fee should also be included along with the application. Crafters who have attended the show in the past do not have to send photos unless there have been changes in merchandise.

Fees

Applications and booth fees (separate checks) **must** accompany entry forms. Applicants that are accepted will receive acceptance letters. Applicants not accepted will receive notification letters which will include the booth fee checks that accompanied the applications.

NO REFUNDS FOR CANCELLATIONS AFTER MAY 3, 2019.

Eligibility

The Greene County Partnership reserves the right to remove any work which does not reflect the caliber of that presented in the slides or photos, or work considered to be in poor taste. All crafts, traditional and contemporary, including photography and painting, will be considered. All work must be original to the exhibitor. Any commercially-made embellishments must be subordinate to the handcrafted work.

Sales

All sales must be handled by the exhibitor. Local sales tax must be collected. Tax materials will be in the registration packet received at check-in.

Setup

Exhibitors are responsible for their own displays, including tables and tents. See calendar for set-up times. The show will be held, rain or shine, and each exhibitor should make arrangements for wind or rain. Arrangements for electricity have to be made in advance. There will be an additional cost of \$20 for electricity. Your vehicle may not be brought onto the grounds until 5 p.m. after the festival hours.

Food Booth

Profit and non-profit food booths will be accepted on a first-come, first-served basis. Food vendors **will** be allowed to sell soft drinks. All food vendors will pay \$325 per booth space, the application fee of \$5 and the \$20 electricity fee.
